A 10'x10' outdoor booth space will be available in the park. The booth fee for 2023 is \$200.00. There is a non-refundable jurying fee of \$25.00 that should accompany your booth payment. Total cost: **\$225.00**

All applications must be accompanied by payment to cover the total cost. If you are not selected by the jurying committee, the booth fee will be refunded to you.
